Small Scale Funding Agreement with Help and Shelter, "Community-based action: Violence Against Children and Women".

Based on the Country Programme Action Plan between the Government of Guyana and UNICEF, UNICEF agrees to co-operate with Help & Shelter as described below.

Work plan results/key actions to which the small-scale funding agreement contributes: "2.3.6 Community based interventions".

2. Activity or activities to be carried out under the small-scale funding agreement:

- i. Drafting, consulting, agreeing and finailising the community based protocols for abuse prevention and response.
- ii. Training on the use of the protocols (reporting, follow-up, documentation including of lessons learned etc.).
- iii. Establishment of community-based teams through social mobilization and awareness sessions on violence and abuse and parenting sessions for both rights holders and duty bearers in communities.
- iv. Monitoring the use of the protocols e.g. through documentation of human interest stories, successes/challenges- including bottlenecks at national level, identification of critical cases for follow-up and use of violence related data for advocacy.
- v. Drafting community-based action plans (based on knowledge gained) for the protection, prevention and treatment of all matters related to the protocols. (Note that the actions plans will include explicit reference to the plans).

- iii. Increased use of CSA data and reporting to support accountability and quality of services and response as part of community-based/NGO advocacy.
- iv. Increased support and networking on CSA and CSA-related issues.
- v. Promotion of high demand by parents and communities for high quality services through community champions.
- Starting and ending dates for implementation of the activities: November 10 2014 to April 10 2015
